# NOTICE OF RACE

The 2012 RS:X Andalusian Championship for the RS:X men, women and Youth 8.5 Classes will be held in waters of Bay of Cadiz, Puerto Sherry (El Puerto de Santa María) between 3 to 5 February 2012, both inclusive. The Regatta is organized by the Andalusian Sailing Federation on behalf of the Consejería de Turismo, Comercio y Deportes de la Junta de Andalucía with the cooperation of Puerto Sherry.

### 1. RULES

- 1.1. The race will be governed by the "rules" as defined in the Racing Rules of Sailing 2009-2012, RRS
- 1.2. The Competitions Regulation of the Andalusian Sailing Federation (ASF).
- 1.3. The official languages of the regatta will Spanish.
- 1.4. Each competitor shall wear a properly secured personal flotation device according to CR 1.2 (a) at all times while on the water except when temporarily adding or removing clothing, without the need for display of the Y flag. This changes rule 40. This rule also applies to support boat personnel

### 2. ELIGIBILITY AND ENTRY REGULATIONS

- 2.1. All entries shall meet the requirements of ISAF Regulation 19 – Eligibility Code.
- 2.2. The Event shall be open. (This changes the Competitions Regulation of ASF 1.9.4)
- 2.3. The sailors competing in RS:X 8.5 Youth Class shall be Under 19 years - born after 1994 - on 31 December 2012
- 2.4. Those competitors eligible to compete in the RS:X 8.5 Youth event will also compete in the more senior event.
- 2.5. A minimum of 5 entries is required to validate Championships in a men/women/youth division.

- 2.8. Events for which there are fewer than 5 entries by **29<sup>th</sup> of January 2012** may be cancelled.
- 2.9. Late entries may be accepted at the criteria of the Organising Committee.

### **3. REGISTRATION**

- 3.1. Each competitor shall register and sign the registration form in the Race Office before 1200 on the 3<sup>rd</sup> of February.
- 3.2. Each competitor shall produce the following documents before the end of the registration period.
  - Entry Fee payment.
  - Evidence of valid third party insurance with a minimum cover of €300,000
  - Identity Card or Passport.
  - Proof of 2012 Federation Licence (for the Spanish sailors)

### **4. FORMAT**

- 4.1. Men and women shall race separately.
- 4.2. There will be a maximum 9 races in a series over 3 race days.

### **6. RESULTS AND TROPHIES**

- 6.1. Different overall results will be established for the Classes properly constituted
- 6.2. Title of the Andalusian Champion will be awarded by the Andalusian Sailing Federation to the winner of each Class with andalusian sailing licence and competing by an andalusian club.
- 6.3. The trophies list will be published on the official notice board at the beginning of the Event.

## **7. DISCLAIMER OF LIABILITY**

- 7.1. Competitors take part in all races at their own risk. The LOA or any of their officials or representatives or the sponsors or their officials or representatives are not responsible, under any circumstances, for any damage, loss or injury either ashore or on the water either to persons or equipment, which may result.
- 7.2. Participation in this event, supporting events and in each race in them is at the sole discretion of the sailor and at his/her own risk. Notice is drawn to RRS4.

## **8. INSURANCE**

- 8.1. Competitors shall possess valid third party liability insurance with a minimum cover of €300.000
- 8.2. Coaches and support boat drivers shall also have valid third party liability insurance with a minimum cover of €300.000.
